

Vendor Terms and Conditions of Use

Haliburton County Fair

1. Minden Agricultural Society reserves the right to restrict the type and number of vendors/concessions in attendance at the Haliburton County Fair.
2. Vendors will be designated areas. Occupancy and use shall be confined to designated areas. Vendors shall be responsible for leaving the area in a neat, tidy and clean condition.
3. It is understood that the rental covers ONLY space and power where applicable. Tables/chairs or tent(s) are NOT included.
4. Locations with electrical outlets are limited. Please confirm requirements ASAP. Extension cords will not be provided.
5. **No generators allowed unless specifically approved by the Society prior to the fair.**
6. The Minden Agricultural Society is NOT responsible for loss of business and/or equipment including display material due to weather conditions resulting in spoilage, theft, water damage, fire or accident during the period of agreement.
7. Vendors shall supply their own third party liability insurance, naming Minden Agricultural Society and the Township of Minden Hills as co-insurers, and submit proof thereof to the Minden Agricultural Society with signed contract.
8. Food vendors are responsible for their own Health Board approvals / permits and submit proof to the Minden Agricultural Society with your signed contract.
9. Each Vendor attending at the fair will be provided 2 passes for entry to the fairgrounds.
10. Non-Profit organizations are required to pay upfront and will have fee reimbursed after fair.
11. **All vendors must be operating when fair opens and must stay open until closing (unless alternate arrangements have been prior approved by Agricultural Society).**
12. Vendors may not under any circumstances, sublet all or any portion of their booth space rented under the terms of this agreement.
13. Vendors may not operate any other business of sale of goods other than what is listed on the contract.
14. Sale of Vendor lottery / draw tickets must be approved in writing by the Society.
15. The decision of the Minden Agricultural Society Board is final.
16. Cheques should be made payable to The Minden Agricultural Society.
